3. Late Fees

- 3.1. A \$25 late fee charge will be applied to all payments made after the 3-day grace period. Missed payments will be applied to the next month plus the \$25 late fee. Your tour will be automatically cancelled after two missed payments. **NO EXCEPTIONS!**
- 3.2. There will be no refund of the deposit or any payments that were made for the tour if it was cancelled due to missed payments. Your tour must be paid in full by June 30, 2024. Final payments not received by June 30, 2024 will be charged an additional \$25 for every 3 days payment is not received. If a late final payment is received without the additional late fees included, your tour will be cancelled, and **NO refund** will be given. This is **NON-NEGOTIABLE**.

Invoices

Payments must be made to Globetrotting Sistars, LLC

Once payment is received, you will receive an invoice/trip documents within 24hrs not including weekends. It is your responsibility to provide an email address for the docs to be sent to. Duly note if you choose to use PayPal (www.Paypal.me/GlobetrottingSistars) GS cannot absorb fees, and if funds are put on hold we cannot provide documents until they are cleared. Credit we must have a total of 15 or more persons for you to utilize your full credit. If we have less than 15 persons for the tour you can only use 50% of your credit towards the tour.

Refund & Cancellation Policy

You have 90 days before the scheduled tour (July 19, 2024) to cancel. If you cancel your tour after July 19, 2024, there is no refund of any payments, **No Exceptions**. If you cancel your tour before July 19, 2024 you will receive 25% of your payments made to date, **not including your deposit**. You can opt to transfer your funds paid on the tour to date (**deposit is not included**) to a future Globetrotting Sistars LLC tour that you are **NOT** currently making payments on or receive a refund of your funds paid on the tour to date (**deposit is not included**) within 14 business days. If your tour is cancelled due to you missing two tour payments, you can not apply the deposit to any future Globetrotting Sistars LLC tour no matter when the tour was cancelled. In case it is necessary to cancel your tour due to a medical or personal emergency, your travel insurance policy can reimburse you for the cost of the tour. Please get a policy that allows you to cancel for ANY reasons.

Please carefully read your travel insurance policy to ensure reimbursement of your tour costs under ANY circumstances. We recommend Allianz Insurance company though you can choose any company. Proof of international medical/travel insurance is required to be submitted to typhanielynych@yahoo.com no less than 30 days before the tour.

Covid-19 Cancellation Policy/Civil Unrest/Terrorism/War

If Globetrotting Sistars, LLC or its vendors cancel the tour at any time as a result of terrorism, war, civil unrest or border closures due to Covid-19 the tour will be rescheduled for a later date within 12-24 months of cancellation. If we're still unable to reschedule within 12-24 months due to circumstances beyond our control, then a company credit will be issued minus deposit/Hotel Cancellation Fees. No refunds, only company credit will be issued, **NO EXCEPTION!**

Tour Reminders

★ Etiquette:

Remember ladies, you will be visiting a country whose customs may differ from what you are used to in your home country.

Please be aware of the following while we are in Morocco:

★ Tipping:

Tips are customary for performances and entertainment in Morocco so please make sure you set aside funds for this, especially if you want to take individual or group pictures with performers. It will reflect badly upon yourself and the group if you attempt to sneak in photos or take pictures without tips/donations. Remember this is their livelihood and they rely heavily on our tips/donations to support themselves and their families.

Tips are customary for guides, hotel staff (housekeeping/maids) and restaurant servers. Be prepared to leave a tip when receiving a service in Morocco. While it's not mandatory, generally a tip is expected and always appreciated. Please avoid being overly generous, as this may appear that you are flaunting money, but do leave enough to show appreciation for the services you receive.

★ Hotel Housekeeping/Maid Service

Housekeeping/Maid Service: \$2-\$3 per night, and up to \$5 in high-end hotels. You can leave the tip on your pillow or in a place where it will be easily located. Tips are recommended to be left per night as the housekeeping staff will not be the same person for each night of your stay.

★ Bus Tours:

Bus Tours: (several hours or less), tip your guide 10% - 20% of the cost of the tour. For driver/tour guide for one week the suggested amount is \$4-\$5 per day per passenger. You can give the tip at the end of the week to the driver in an envelope. The preference is for the tip to be given individually rather than as a group. While tips are not mandatory, they are greatly appreciated for all the work that goes into their job catering to travelers.

★ **Bargaining:**

Except for goods in supermarkets, high-end shops, hotels and restaurants, nothing in Morocco has a set price, so bargaining is expected. The seller may offer the item at 30% - 50% more than what they expect for it, so your counter offer should be lower than what you are expecting to pay. You and the seller will go back and forth until an agreement is made. If you can't come to an agreement, don't get frustrated. Move on and find another vendor and you may even get the price you are looking for once you've walked away. Remember to keep it fun and light. Our guides will also help you to get great bargain prices.

★ **Activities**

Activities unless stated are not optional. If you choose to opt out of a scheduled activity Globetrotting Sisters LLC will not be responsible for creating an alternate itinerary. Any excursions or activities that you choose to participate in outside of the designated tour itinerary are at your own discretion. Globetrotting Sisters, LLC will NOT be held liable for your safety and security or any costs you incur.

When In Morocco

- ★ Conservative dress is essential for all. Pack clothing that covers both shoulders, arms and knees; women in particular should take care to cover cleavage and wear loose-fitting clothing like long flowing skirts or maxi dresses, rather than figure-hugging attire. It's a good idea to pack a scarf/wrap or light cardigan to cover your shoulders (and hair if entering a mosque) without overheating.
- ★ Bikinis, shorts and swimwear are acceptable only on resort beaches.
- ★ Also on the must-pack list are comfortable walking shoes. While sandals are acceptable attire, the streets in Morocco, particularly in villages and deserts, aren't spectacularly maintained (uneven roads, potholes, etc.) and can be unclean.
- ★ Alcohol is available at bars/hotels, drunken behavior is considered offensive.
- ★ Ask for permission before taking pictures of people or private houses.
